# Molecular HIV Surveillance







**Bodily integrity** = the right not to have one's body touched or interfered with without consent; a right to be free from physical interference

**Bodily autonomy** = Principle of Western biomedical ethics, right to make decisions for yourself, which may or may not affect your physical body





## **Informed Consent**

- Right to make decisions about what medical treatment you will
  or will not accept
- Duty for providers to disclose information + right to make decisions about your body
- Puts autonomy into action and protects bodily integrity
- Exists due to many violations after the Nuremberg Code in Europe, and massive lawsuits in North America (i.e., Tuskegee, Mk-Ultra, forced sterilization, tests on prisoners and military, malnutrition experiments in residential "schools") – we do not trust these systems as they are founded on these practices.



The right to bodily autonomy and integrity is enshrined in medical ethics, research ethics, and laws (depending on your country it may be in your constitution, in privacy laws, and various other legal frameworks.


Public health is often at odds with bodily autonomy and integrity as the ethics of public health aims to suspend the rights of some for the benefit of the population.

#### But who is the "public" in public health?






Molecular surveillance proponents have said the data they study is "molecules not people." But molecules are connected to people & people are situated in social contexts.







This is an issue about violations of ethics, evolving conceptions of ethics, & the rights to privacy, bodily autonomy, & consent of people living with HIV in contexts of criminalization



### Data is not benign. We must be wary of how data can be weaponized.





Molecular HIV surveillance analysis <u>starts</u> with our blood tests. The unique genetic make-up of the virus in our blood is translated into digital form and shared inter-institutionally (for clinical purposes and public health purposes).

Results from our clinical blood tests are re-used by public health authorities without our knowledge or consent for surveillance purposes.

Public health authorities use genetic sequences to identify <u>clusters</u> (i.e., transmission networks happening at higher rates than normal).





To be meaningful analytically, genetic sequences are linked to other sources of demographic information (e.g., age, race, sex assigned at birth, gender, migration/citizenship status, drug use history, sex work history, sexual practices - and whatever else people share in clinical encounters).







- → Being used widely around the world
- → Know your HIV surveillance system!
- → Often tied to USAID funding, such as in Nigeria
- → Targets the most socially marginalized, including migrants, people who use drugs, trans people, people who sell sex.
   The same populations who are targets of criminalization.







### Concerns

- → Lack of informed consent
- → Intensified stigmatization (MSM case in Kenya and drug users in US)
- → Criminalization
- → Engagement with people living with HIV
- → No demonstrated impact
- → Privacy

#### RECOMMENDATIONS

Based on our global scoping review of MHS research and intervention literature, we have produced a number of recommendations for a wide range of stakeholders which can be found at the end of the document. The most important of these are:

- 1. Take seriously and act upon community concerns about MHS.
- 2. Respect the bodily autonomy and integrity of people living with HIV in all our diversity.
- 3. MHS implementers must demonstrate a clear public health benefit that outweighs the potential harms of MHS, including by ensuring protections (i.e., data privacy, legal protections, social harms prevention, etc). These demonstrated benefits of MHS must measurably include people living with HIV.
- 4. Providers ordering HIV sequencing must inform people living with HIV about how their blood and data are being used for MHS purposes and be allowed to withdraw consent if they so wish, without fear of negative consequences to their HIV treatment and care.
- 5. Implementers of MHS should publicly advocate against punitive or coercive laws and policies aimed at people living with HIV and ensure that MHS is never used in criminal, civil, or immigration investigations or prosecutions.

## MORATORIUM

#### People Living with HIV Need Comprehensive Education, Consent and Safeguards on Our Data

HIV surveillance is widely recognized as a public good. Public health leaders often say that they count on surveillance data to guide their interventions. However, for people and communities affected by HIV, surveillance may act as a double-edged sword, especially when it participates in stigmatizing and even criminalizing them.






#### Criminalization of Pregnancy

- Someone arrested for reasons related to their pregnancy, or where the terms of their bail, sentencing, or probation are heightened because they became pregnant after being charged with an unrelated crime. - Pregnancy Justice
- People who use drugs, BIPOC, and low-income people

#### Fetal Personhood Movement

- Legal rights attached to fetuses, embryos
- Fringe idea entered mainstream in collision with "war on drugs"
- Right to bodily autonomy for people with capacity for pregnancy diminished



#### Surveillance, Criminalization, and Bodily Autonomy



- Fetal personhood movement paves way for more surveillance
- Drug testing pregnant people without informed consent
- Providers facilitate criminal and civil consequences for pregnant people








#### Resisting Criminalization and Surveillance

- Educating and organizing providers to break up with the police
- Digital privacy education for abortion seekers, helpers, providers - without fear mongering!
- Policy "shield laws"
- Abortion funds as reproductive justice hubs


